1. Course achievements

Adjustment & Remittance Transactions),this course also includes all information about the types of messages that may occur during the implementation (Exception Messages) and to identify the meaning of each message, which ultimately leads to how to pay attention to all the data for the success of the transactions, as well as avoiding the occurrence of any external influences for the lack of success of the movement as accompanies this study.
