- Core Banking Systems – FLEXCUBE Track
- In addition to specialized training courses to develop personal and banking

3- DURATION & TRAINING METHODOLOGY

- The program duration will last from 5 to 6 months
- Daily lectures will take place in training classes that require full-time attendance
- A graduation project will be needed to be submitted that targets the requirements of the banking sector

4- ARE THERE ANY FEES ASSOCIATED WITH THE DIGITAL WORKFORCE DEVELOPMENT INITIATIVE?

This round of the Digital Workforce Development Initiative is financially funded by Banque Misr for those who pass the prescribed submission requirements and assessments by The Egyptian Banking Institute.

6- WHAT ARE THE MILESTONES OF THE INITIATIVE? WHAT WILL HAPPEN AFTER I APPLY?

- After registration, the best cadres will be contacted according to their specialization and assessment, provided that they pass the submission requirements to be included in the assessment stage, during which they will be tested in: English language, psychometric, and a technical test.
- After passing the assessment's phase, they will be contacted to start the technical tracks' training phase, then the training phase of developing the personal skills, then the last stage of preparing a graduation's project and the final exam's stage.

7- ACCEPTANCE CRITERIA

Candidates must pass the assessments, which will be done after the registration

8- THE NEEDED CRITERIA TO JOIN

- Fresh graduates from public and private universities that are accredited by the Supreme Council of Universities and graduates from:
- Faculty of Engineering (Department Computers Science)
- Graduates of faculties of computer science, information technology
- Graduates of faculties BIS (Business Information Systems)- MIS
- The applicant must be a graduate of the last 3 batches from 2022 to 2024.
- For males, the applicant must have performed the military service or obtaining an exemption or postponement.
- Good English language (reading and writing)
- The applicant should not have previously conducted any exams at Banque Misr.
- No consanguinity up to the third degree.
- Full-time for a period of not less than Five to Six months (during the specified period of training)

9- COULD GRADUATES OF OTHER FACULTIES APPLY?

The study is specialized only for graduates of the assigned field.

10- ARE THERE OTHER SPECIALIZATIONS THAN THE ONES ANNOUNCED?

There aren't at the time being, but there could be different majors according to the market's situation and demand.

11- CAN I JOIN MORE THAN ONE TRACK?

Only one training track will be joined.
